Dear members and friends of St. Mary's,

2022 STEWARDSHIP FAQS

What is pledging? Pledging is a covenant made to contribute a certain amount of money to St. Mary's over the period of a year. We are asking parishioners to let us know what they will be able to contribute to St. Mary's during 2022 so we can plan our mission and ministry for the coming year. It's necessary to know what St. Mary's will receive in pledges so we can prepare a budget for 2022. Pledges can be given weekly, monthly or quarterly throughout the year or in a one-time lump sum. All pledges large and small are valued as a commitment in faith to our church community.

What if I put money in the offering plate – doesn't that take the place of a pledge? Putting money in the offering plate is a wonderful spiritual discipline, but it doesn't take the place of a pledge. Simply put, it's not possible for the Vestry to plan a budget or operate our church given the fluctuating and uncertain nature of plate offerings. By making a pledge, you are giving the Vestry the necessary tools to sustain church operations and support our ministries over the year.

What if I can't meet my pledge? Things can happen over a year that may change your circumstances. You can contact our Rector, Mother Allison, to let her know you need to revise your pledge and whether or not you desire pastoral care and support. We value you no matter how much you give and God honors your faithfulness.

Who at St. Mary's will know what I have pledged? The Church Treasurer and the Administrator (Julie Taylor) will know your individual pledge amount. Mother Allison and the Vestry will know only the total dollar amount of all the pledges received.

Is pledge money used to support The Branches? Due to the overwhelming response from local churches, organizations and individuals, The Branches has received enough support that has alleviated St Mary's financial responsibility at the present time.

How are financial decisions made at St. Mary's? Financial decisions are made by the Vestry of St. Mary's with input from the Finance Committee. The Vestry is the "board of directors" of the church. Members are elected to three-year terms. Officers include the Senior Warden, Junior Warden, Treasurer and Clerk.

Does St. Mary's receive any financial support from the Diocese of New Jersey?


St. Mary's helps to support the Diocese through an assessment that is based on our operating expenses. The Diocese provides pastoral support to priests, support for young people, educational programs and outreach. The Diocese has made money available to St. Mary's through an interest-bearing loan and that information is included in our Annual Report.

How does St. Mary's meet its expenses? St. Mary's budget includes salaries and benefits for a full-time Rector and our administrator, along with other lay staff. It also includes expenses for Church property and grounds, operating expenses such as utilities, mission and outreach. Pledges meet a portion of our budget and the remainder comes from the Church investment account as needed. Please look over our Annual Report if you want to know where the money comes from and how it is spent. It is important to remember that the salaries of our clergy and staff are part of our mission of providing the sacraments of the church, pastoral care, education, and music ministry.

Who needs to pledge? We ask all members to pledge. Giving on a regular basis over the year provides needed support.

Is Stewardship just about money? We value the gifts of time and talent that all of our members give. We value each person who walks in our doors as a precious gift.

Are my donations tax deductible? Yes. Per IRS regulations, contributions for each year must be received or postmarked by December 31 of that year in order to receive credit for that year's tax purposes.
